Madam/Sir,

In continuation with this office letter no. Med/MS/103(24)/2022 dated 18th day of March, 2022, I am to submit the following clarifications for your comprehension:-

(i) Approved designs/themes of banner/poster/standees with measurements are attached herewith, which may be suitably modified and printed in required number of quantities on station to station basis and the same be used for both phases of Mediation Fortnights;

(ii) Approved audio message is attached herewith, which may be used in publicity tableau/ local miking etc.;

(iii) One micro level Mediation Awareness camp may be organized in each of the sub-divisional court for the year, 2022 except the sub divisions of Berhampur Sadar, Raigaunge, Medinipur Sadar, Jalpaiguri Sadar, Chinsurah, Siliguri, Diamond Harbour, Durgapur, Bolpur, Haldia Portblair, Purulia Sadar and Kolkata where Regional Conference on Mediation have been planned by the Hon'ble Committee; also Mirik, Garubathan, Mongpu and Malbazar Bar Association representatives may be requested to attend the nearby sub-divisional court premises for taking part in the scheduled micro level Mediation Awareness camp;

(iv) Publicity tableau may preferably be travelled through populous areas of the local jurisdiction like market places, ferry ghat, railway stations, bus stands etc. However, for the stations of Mirik, Garubathan, Mongpu and Malbazar publicity tableau may not be hired;

(v) Total expenditure budget for each of the station may not increase Rs.15,000/- (Rupees fifteen thousand only) including both the phases of Mediation Fortnights. For example- a district having three sub-divisions including Sadar may spend upto Rs.15,000/- x 3 = Rs.45,000/- for the entire fortnight calendar for the year, 2022;

(vi) All expenditure bills may be raised with supporting original documents/ certificates/ vouchers by the concerned DLSA. No advances can be paid in this respect;

✓ (vii) Schedule of Micro Level Mediation Awareness Camp and the details of available Trained Judicial Officer Mediators in each of the sub divisional court, who may be engaged for the aforesaid purpose, may kindly be shared with this authority positively by 28/03/2022, in order to enable the undersigned to engage resource persons from other stations;

(viii) Prominent photographs of the Mediation Fortnights, Micro level Mediation Awareness Camps and Publicity tableau may be forwarded to the undersigned for being place in the next issue of the Mediation Newsletter of the Hon'ble Court;

(ix) Mediation leaflets of Calcutta High Court may as far as practicable be collected from the Mediation Centre, High Court, Calcutta, 5, Council House Street, Ground floor, Kolkata-700001;

(x) A video conference in this regard has been arranged by this authority on 31/03/2022 at 05:00 P.M. for making any and all required clarification to the Chairman and Secretaries of concerned DLSA Authorities. The joining link of which will be provided in due course.

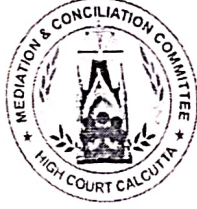
