CORRIGENDUM

In continuation and in corrigendum to our earlier notification no. 01 /DLSA/South-24-Pgns/2025 Dated. 09.04.2025 & 02 /DLSA/South-24-Pgns/2025 Dated. 09.04.2025, I am to request as follows vide letter no. 1129/SLSA-143/2000 Dated 06.05.2025.

- (a) The empanelment process by any Legal Services Institution must begin with the inviting of individual applications from willing legal practitioners, and no bulk forwarding of names by the Local Bar should be entertained. Fresh invitations issued in this regard may mention that the existing scales of honorarium payable for various types of professional services rendered to legal-aid claimants are likely to suitably and upwardly revised;
- (b) A legal practitioner expressing willingness for empanelment must submit with her/his application-enrolment certificate, five copies of judgments [civil or criminal or both] that records the applicant's appearance as lead counsel for any of the parties, as well as the arguments that were advanced by her/him, and five copies of cross-examination conducted by the applicant. Appellate judgments and contested sessions judgments are to be given additional weightage at the time of selection;
- (c) Willing legal practitioners eligible for empanelment in Group A [more than ten years of practice] and specialization in the civil laws must submit contested judgement in probate matter or PP Appeal or L.A matter or matrimonial cases or guardianship matter, in addition to appellate judgments recording her/his arguments;
- (d) In addition to the above, any applicant with not less than seven years' of practice must submit IT Return of three years immediately preceding the current year.
- (e) In order to qualify in Group B of the panel, an applicant's average annual income calculate on the basis of her/his (three) IT Returns must not be less than Rs. 5,00,000/- In case of empanelment in Group A, the average annual income must not be less than Rs. 8,50,000/-.
